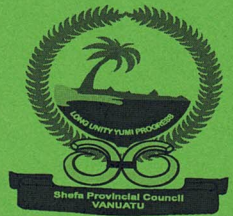

Conformément au paragraphe 5 de l'article 13 de la loi, les titulaires d'une patente apportant en cours d'année une modification à la nature ou à l'étendue de leur commerce ayant pour effet de les soumettre à une nouvelle catégories de patente doivent en informer l'autorité compétente. Les commerçants sont donc invités à consigner les données (valeurs des importations et nombre de personnes employées dans le commerce notamment et le chiffres d'affaires annuel) qui leur permettront de satisfaire à cette obligation légale.

Notice:

Section 13 (5) of the Act requires proprietors of businesses to notify the Licensing Authority of any change occurring during the licensing year, in the nature or extent of the business which would render the proprietors liable to a different license fee. Proprietors should therefore keep adequate records (including import and export values, numbers of persons employed in the business and annual turn over in order to be able to fulfill this statutory duty)
